- 2. Bob Mayhew appointed as Parliamentarian; AGENDA for meeting reviewed, no discussion, no changes. Motion to accept agenda as printed Kathy, Second Floyd, motion carries.
- 3. MINUTES (January 2020 Meeting), no discussion, no changes. Motion to Approve as posted Kathy, second Floyd, motion carries.
- 4. Treasurer's Report: Kathy Ives, Balance in Account is \$20154.89, generally have around \$25,000. Balance currently low secondary to decreased number of tournaments this year (revenue comes from head tax).
- 5. Approval of new council: Van Presented 2020 Regional Council members, only change from 2019 is Bubba Powell replaces Tim Cost as Councilor for Cedar Ridge Skiers. Motion by Bob to seat Council, second by Floyd, Motion carries.
- 6. Junior Development: Lauren Malitz, Committee Chair
- A. Recap (2020 JD Tournament and Clinics / no tournament or clinic this year)
- B. Site selection for 2021 (Jim Thompson / Ski Texas plans to host 2021 JD Clinic in lieu of not being able to host in 2020)
- 7. EVP's Report, Van Parker:

It's going to be a difficult year for us in terms of membership and sanctioning revenue. AWSA has Ben the least impacted of the sports division, however we did see a drop of 6% in membership (down 408, current at 6148). 77 of 381 sanctions have been cancelled or postponed.

Nationals entries is at <u>322</u> as of yesterday. The Towboat Draw for the 78th GOODE Water Ski National Championships is now available to view and download. The Nationals will be held Aug. 4-8 at Tri-Lakes in Zachary, La. Towboat manufacturers Malibu, MasterCraft and Nautique will pull the Nationals.

Nationals Webcast is going to happen, \$10k raised through a go fund me account, many thanks to all who helped make it happen. This should be a world-class webcast with many cameras and live feeds from both lakes with separate announcers. (SCR donated \$500, same with all regions, in lieu of Regional tents this year).

The team skiing commissioners got together and have decided not to have team skiing this year for a variety of reasons but mainly due to lack of participation and states being canceled in many areas.

Officials have a full pass this year on credit requirements:

- Tournaments Tournament reductions for 2024 renewal (judges/ scorers/drivers) and 2022 renewal (tech controllers):
 - AWSA Judges/Scorers reduce from 8 to 6
 - AWSA Assistant Drivers reduce from 8 to 6
 - AWSA Regular/Senior Drivers reduce from 12 to 9
 - AWSA Tech Controllers reduce from 4 to 3
- Clinics no change in requirement since they have three additional years to complete the clinic

Still looking for a scholarship sponsor for B2 and G2 for Nationals overall NOPS winners.

Practice scores are still coming in, this has been really exciting and is working. We've had a good mix of video submissions as well as judges just signing off on scores.

There are 2 methods for submitting practice scores:

- 1. You can submit a video of your practice performance in slalom or trick at https://forms.gle/8efMwUzQWnZWnJJi8. Practice scores will be judged online by a panel of officials where final scores will be submitted online to the AWSA rankings. Videos can be uploaded to AWSA's DropBox at https://www.dropbox.com/request/CliJqh1WzDDvdO9Z2vaN or any other platform such as YouTube. Videos should be named so that we can identify who the skier is and the date of the video, for example, johnsmithjune62020. Trick videos should be submitted as one continuous video for pass 1 and 2. Make sure there is a clear indication of the start of the trick run. Slalom videos should show the boat speed and rope length before each pass and boat times after each pass. Slalom videos only need to be submitted for last completed pass and final pass, for example, if you run 30 mph, 32, 34 and 3 @ 36, you need only submit the 34 and 36 passes on 1 continuous video.
- 2. Practice performance scores in slalom, tricks, or jump can be submitted and signed off by a rated official. You can download a performance card by <u>clicking here (PDF)</u>. This card can be mailed in or uploaded online at <u>https://forms.gle/PCYpk7XsoYAVRDj56</u>. You can also manually enter a practice score at <u>https://forms.gle/6E6tmcRYSK56zTQeA</u>

Practice scores will count as class F scores, which means they cannot exceed Level 5. You only need to have a \$19.95 membership to be eligible to submit practice scores.
